NOTIFICATION

The 22nd October, 2014

S. O. No. 54 dated 22nd October, 2014-- In exercise of the powers conferred by Section 29 of the Jharkhand Taxation on Luxuries in Hotel Act, 2011 (Jharkhand Act No. 21, 2011), the Government of Jharkhand is pleased to make the following Amendments in Departmental Notification No. S.O 181 dated 9th November, 2011

AMENDMENTS

1. Amendment in Rule 3 –

- (i) In sub-rule (1) the words 'Form JHLT 101' after the words' Commercial Taxes in' and before the words 'for registration under' shall be substituted by the words 'Form JCRF(Jharkhand Common Registration Form) including the information as contained in annexure I, II, III and IV annexed to it.'
- (ii) Sub-rule (2) shall be substituted as follows:-

"Such application for registration **shall** be filed—under digital signature electronically through said website and follow the steps/instructions contained in the software specially evolved for this purpose.

Provided the Commissioner may relax the provision of digital signature for a particular period".

- (iii) In sub-rule (2) (c) the words 'JHLT 101' shall be substituted by the words 'Form JCRF'
- (iv) In sub-rule (2) (d) the words 'JHLT 101' shall be substituted by the words 'Form JCRF'
- (v) In sub-rule (3) shall be substituted as follow:"Such an application shall be Signed, as the Applicant, by the proprietor of the business; or in the case of a firm, by the partner authorised to act on behalf of the firm; or in the case of the business of an undivided Hindu family, by the Karta; or in the case of a company incorporated under the Indian Companies Act, 1956 (1 of 1956) or a Corporation constituted under any law, by the Principal Officer or the Chief Executive Officer thereof; or in the case of a society, club or association of persons or a Department of Government or local authority, by the Principal Executive Officer, or officer-in-charge thereof, or declared Business Manager and verified in the manner prescribed ".
- (vi) Sub-rule (4) shall be substituted as follows:-
 - "Where the Registering Authority is satisfied, that the information furnished to him in application in Form JCRF is true and correct, and that the Hotelier is genuine, he shall subject to Rule 4, issue to the Hotelier a Registration Certificate in Form JHLT 102 within five days from the date of filing of such application, and allot him a registration number.

The Registering Authority thereafter may conduct an enquiry within thirty days from the date of issue of such registration certificate, and if upon enquiry anything otherwise than the application in Form JCRF along with the annexure and security furnished thereof are found, the registering authority subject to subrule (5) of this Rule, may revoke or cancel such Registration Certificate".

(vii) Sub-rule (8) shall be substituted as follows:

- "(a) In case a registered dealer appoints a Business Manager, he shall declare the name of his Business Manager in annexure IV of JCRF along with two Passport size photographs of such Business Manager. In case of a dealer already registered under the Act and who has not declared the name of his Business Manager shall submit such declaration in Annexure IV of JCRF separately."
- (b) In case of a change of Business Manager, such Dealer shall inform the Prescribed Authorities within fifteen days from the date of such change and shall file a new declaration in Annexure IV of JCRF after exercising the option in JCAF (Jharkhand Common Amendment Form) for such change".

(viii) A new sub-rule (12) after existing sub-rule (11) shall be added as follows:

"Notwithstanding anything contained in this rule the provisions of Rule 3 of Jharkhand Value Added Tax Rules, 2006 shall mutatis mutandis apply."

2. Amendment in Rule 6 -

Existing sub-rule (6) shall be substituted as follows:

- "(1)An Hotelier registered under Section 6 of the Act, shall inform the Registering Authority in writing within thirty days in the Prescribed Form in Form JCAF along with the registration certificate in Form JHLT 102 issue to him:-
- (i) of any change in the name, address, of the place of branches or discontinuation of the business; or
- (ii) of a change in circumstances of the Hotelier, which leads to cessation of business; or
- (iii) of a change in bank account details.
- (iv) of a change in e-mail or mobile number details or PAN details in case of addition of Partners or Directors.
- (v) any change in no. of Rooms, Type/ Category of Rooms, Tariff / Rent of Rooms.

(2) On receipt of such application along with certificate of registration, the registering authority, shall after making such enquiry, if any, as he deems fit, make necessary amendments in the certificate of registration and such amendment shall operate with effect from the date specified in certificate of registration".

3. Amendment in Rule 7 -

Existing Rule 7 shall be substituted as follows:

- (1) Where a Hotelier ceases to carry on his business, the Hotelier or his legal representative shall apply before the Registering Authority for cancellation of registration within thirty days of the closure of business in Form JCCF (Jharkhand Common Cancellation Form) together with his registration certificate in Form JHLT 102.
- (2) Subject to sub-rule (3), a Hotelier may apply in writing in Form JCCF to have his registration cancelled if,
 - (a) With respect to the preceding period of three consecutive years, the taxable turnover did not exceed specified quantum as specified in Section 3 of the Act.
- (3) The Registering Authority may cancel the registration of a Hotelier who has applied for cancellation under sub-rule (1) or sub-rule (2) of this rule if he is satisfied, after making such enquiry as he deems necessary, that there are valid reasons for such cancellation of registration. The cancellation shall be intimated in Form JHLT 107.
- (4) The authority prescribed may cancel the registration of a Hotelier registered under Section 6 of the Act in Form JHLT 107, where the Hotelier-
 - (a) has not kept proper accounting records relating to any business activity carried on by him; or
 - (b) has not submitted true, correct and complete tax returns; or
 - (c) not complying the provisions of the Act and Rules.
- (5) Wherever any order of cancellation or refusal to cancel of an application is made, the Hotelier shall be given an opportunity of being heard and for this purpose the prescribed authority shall issue a notice in JHLT 301.

(6) Notwithstanding anything contained in this rule, the provisions of Rule 8 of Jharkhand Value Added Tax Rules, 2006 shall mutatis mutandis apply.

4. Amendment in Rule 8 -

- (i) An additional paragraph shall be added in sub-rule(1) as follows:-
 - "In addition to filing quarterly return, every registered hotelier shall file for each day, 'a Daily Occupancy Report' electronically in the prescribed Form JHLT 201A".
- (ii) The word 'July' after the words 'month of' shall be substituted by the word 'September'.
- (iii) Sub-rule (3) shall be substituted as follows:-

"If any Hotelier having furnished a return in Form JHLT 201, finds any omission or incorrect information therein, other than as a result of an inspection or receipt of any other information or evidence by the authority prescribed, he shall furnish a revised return in Form JHLT 201, stating therein the reasons thereof indicating in Form JHLT 201 as "Revised" and also indicating the Period of such revised returns on or before filing of annual return".

5. Amendment in Rule 11 -

(i) Existing sub-rule(2) shall be substituted as follows:-

"The claim for refund under Section 25 of the Act, shall be made by a Hotelier in Form JHLT 108 electronically through department online system, within ninety days, from the date of receiving JHLT 302.

Provided the Commissioner, on application; may condone the delay for filling the claim of refund" .

(ii) A new sub-rule (6) after existing sub-rule (5) shall be added as follows:-

"Notwithstanding anything contained in this rule, the Commissioner may evolve criteria, other than those prescribed in this rule for the purpose of filing application and obtaining refund electronically".

6. Existing Form JHLT 101, JHLT 103 and JHLT 106 shall be substituted by the Form JCRF, JCAF and JCCF respectively as prescribed in Rule 3, 7, and 8 of Jharkhand Value Added Tax Rules, 2006 respectively. Forms are appended to this amendment notification

- 7. Existing Forms JHLT 107, JHLT 108, JHLT 202, JHLT 204 and JHLT 301 shall be substituted by Forms appended to this amendment notification.
- 8. Existing Form JHLT 104 shall be deleted.
- 9. This amendment shall be effective from the date of notification.
