S.O-30- Dated- 25th June, 2017-- In exercise of the powers conferred by Sections 3, 4 and 5 of the Jharkhand Goods and Services Tax Act, 2017 (Jharkhand Act 12, 2017), the Governor of Jharkhand is pleased to appoint the Authorities specified in Column-1 of the Table hereto annexed to exercise and perform the powers and duties respectively conferred and imposed on such Authorities by or under this Act, within the local units of the Area mentioned in corresponding entry in the 2nd Column of the said Table.
